WHAT IS D&L?

The D&L is the central bank of the Archdiocese. Parishes and other Archdiocesan institutions invest reserves in the fund earning a stated rate which is currently 1.0 percent effective July 1, 2009. Interest is paid/credited semiannually on June 30 and December 31. The value of the account does not fluctuate. Parishes needing funds for capital projects, operations etc. borrow from the fund, paying interest quarterly. The interest rate on loans is one half percent higher than the rate paid on deposits. Currently, the deposit to loan ratio is approximately 2 to 1. An independent audit is conducted annually. Profits realized by the D&L remain in the fund.

PARISH CIVIL CORPORATIONS

Each Roman Catholic Parish in the Archdiocese of Lach Roman Catholic Parish in the Archalocese of Dubuque is incorporated as a separate corporation (herein called the Parish Corporation) pursuant to the provisions of the Code of Iowa, as amended. Each Parish Corporation has five members: The Archbishop, the Vicar General, the Pastor, and two lay members appointed by the Archbishop. The five members also act as the Board of Directors of the Parish Corporation. CLUSTER FAITH FORMATION REPORT

The Faith Formation (FF) program runs through the school year and allows us 30 times to meet with the school-age students for 1 hour sessions. This year we have student enrollment of St. Bridget - 51; St. Mary - 43; and St. Patrick -83. Six active seniors are involved in their parish life within the Cluster.

Youth Events

Prayer: We have added Adoration and Masses to the Faith Formation program as well as confession. We are stressing the interior life of the faith to help prepare the youth to live it day in and day out. We are also continually trying to get parents involved by inviting them to classes, Masses, and Adoration.

Action: Our youth have had the opportunity this past year to attend a middle school Rally, a High School Rally, and a Diocore Youth Rally. There have and will continue to be events like the St. Mary Fall Festival, St. Mary Fish Fry, Knights of Columbus Soup and Sandwich Dinner, along with other Cluster Service opportunities. We hope to get our NCYC youth involved in the Liturgy via lecturing, being an EMHC, and Altar Serving.

Vacation Bible Schools: This past summer we had over 35 students participate at St. Mary (5 came from St. Mary). We had over 70 students at the Monona VBS - 13 were catholic.

Totus Tuus: We had over 70 students participate in Totus Tuus 50+ came from within our Cluster. This program allowed for many young people to get involved with their faith. It also included many adults and families. We are very excited to offer the Totus Tuus program again this coming summer in July 2016.

NCYC: 16 students from our Trinity Cluster are attending NCYC in Indianapolis from November 19-22. NCYC has offered many opportunities to get involved from the monthly gathering to our various fundraisers.

Christmas Programs: Christmas Pageants and Christmas Caroling will be shared by our youth. We will add a caroling trip for St. Patrick Youth as we have had at St. Mary. This year the "Holy Walk" in Postville is not included.

Youth teaching: We currently have two youth providing ministry as catechists at St. Patrick. We hope to get some of our confirmation students involved in this next year. Our active high school seniors have an opportunity to attend a Teens Encounter Christ Retreat (TEC) this year in the spring.

Adult Faith Formation

We offered different programs for adults in our cluster.

Adult Faith Formation in Spanish: 16 Hispanics are engaged in adult faith formation with Father Nils. This program is intended to prepare men and women to receive different sacraments of the Church. Classes meet once a month at St. Bridget Parish Hall.

RCIA: We had one person enter the Church last year at Easter-Laurie Helgerson from St. Mary Parish.

Vatican II Video Series: During Lent of this past year we used a video series in commemoration of the 50^{th} Anniversary of Vatican II as a spring board for discussion at each of our Parishes after Daily Mass.

Adoration & Reconciliation: We incorporated Adoration into Faith Formation and invited Parishioners to attend. Adoration will be offered during the upcoming Advent and Lenten Seasons.

Archdiocesan Events: Members of our cluster have participated in the Archdiocesan Adult Rally in Waterloo. Currently, we do not have anyone involved in the Impact Adult Lay Formation Program. Our latest Impact participant was Linda Plaht from St. Bridget. She graduated on May 9, 2015.

Liturgical Ministries: Recently, we commissioned all those in the very important role of serving our cluster through liturgical ministry.

Parish Life: Our parish life committees are offering opportunities for our parishioners to actively live out their faith in service of one another.
